This letter will explain the changes incorporated with the Homechoice Claria APD system software and what to expect to complete the update for your patients.

Why is the software changing?

As a pioneer in remote patient management, Baxter's data communication system powering Sharesource has been hard at work these past years, transferring data with safety and security in mind. A new IT infrastructure is coming to maintain our high standards for data security and safety. To prepare for this new IT infrastructure, your patients' cyclers require new software. Rest assured, the Claria cycler experience and your Sharesource experience are unchanged by this update. Please note that this important update is required for cyclers to connect to Sharesource moving forward.

When will the software upgrade occur?

The new version, 12.006, will be arriving via remote deployment to your patients' cyclers in the coming months.¹ We will be informing patients of the upcoming software update and providing contact details for technical support and troubleshooting.

What changes have been made to the software?

The new software update will help improve data management and security. Both communication systems will remain active through 2023. Devices that do not receive the update will be unable to connect to Sharesource after January 2024.

What if my patients are using a software version earlier than 12.002:

At the time of 12.006 deployment, patients using version 12.002 will already hold a copy of the latest PATIENT GUIDE, but other patients using older software will not. In order to comply with medical labelling requirements Baxter will send a copy of the current PATIENT GUIDE to each patient who doesn't already hold one.

BELOW IS AN OVERVIEW OF HOW TO UPDATE YOUR CLINIC CYCLER(S):

Keep your Clinic Cycler(s) Connected:

Cyclers must be connected to Sharesource to receive the update. If your connection to Sharesource has been interrupted, you may not receive the software deployment automatically.

What do I need to do to receive this upgrade?

Install: The software update will be automatically sent to your device and will start when the device is turned on and connected to Sharesource via your internet modem. As the software updates, the Homechoice Claria screen will display a progress bar. The update will take about 15 minutes.





Confirm Setup:



In some cases, patients may be asked to enter their unique patient activation code (PAC) first used when activating Homechoice Claria. If a patient cannot locate his/her PAC, it can be found within the Sharesource platform in the "Device Settings" screen.
