

Privacy Notice

This Privacy Notice will provide you with information on the data processing activities of Baxter Healthcare Corporation, located at One Baxter Parkway, Deerfield, Illinois 60014, together with its affiliates and subsidiaries (collectively “Baxter,” “we,” or “us”). For more information about Baxter’s affiliates and subsidiaries, please contact us using the information in the Contact Us section below.

This Privacy Notice applies to “Users” of the **My AK 98** App (the “Service”). Please note that health care professionals – not individuals or patients - are the intended users of the Service and the Service does not process any patient data.

This Privacy Notice provides you with information on how Baxter will process your personal data and how you can exercise your rights regarding your personal data. If you are based in the U.S., please also see the "U.S. Supplement" attached to this Privacy Notice.

What personal data we collect

We may collect, use, store and transfer the following categories of personal data about you:

- First name and last name
- Work telephone number
- Email address
- Information regarding your title and profession, including place of employment (which includes the name of the state) or affiliation such as division, company entity
- Your browsing activity on the Service

Why we collect your personal data and how we use it

Baxter may collect your personal data and use it to:

- operate, support and provide the Service;
- support and establish your account and to assist with your registration as a User;
- enable you to log in to your account;
- provide maintenance, support, troubleshooting and upgrades for the Service and to provide technical support;
- respond to your requests, inquiries or questions, and to conduct surveys related to the Service;
- detect and help protect against security incidents and unauthorized access to or activities in relation to the Service; and
- carry out the purposes established in any agreements between you and Baxter.

We may also collect anonymized information about your usage of the Service through the following tracking technology:

- *Unity Analytics*: Unity Analytics uses cookies to collect data such as total usage time of all users per day, number of daily active users, and number of individuals visiting specific pages. Your data will only be collected if you consent to the use of Unity Analytics when using the Service. Baxter will use this data to monitor and analyze the usage of the Service in order to understand how Users use the Service and to improve the Service.

Who may receive your personal data?

Personal data may be accessed by Baxter employees around the globe who support the Service. For example, Baxter employees belonging to the Baxter Global Business Unit team may access personal data in connection with providing you the Service. Other Baxter employees serving as administrators or other support staff may also access your personal data in connection with your User account.

Baxter may use service providers and other business partners to help us process your personal data. Baxter has data processing agreements in place with its service providers to ensure they provide an adequate level of protection for your personal data. Service providers are authorized to use your personal data only as necessary to provide these services to us.

International transfers of your personal data

Baxter is a global company with global affiliates, and therefore we use global vendors, subcontractors, systems, and applications. As a result, the personal data that we collect and generate about you may be transferred, stored, or accessed in a destination outside of your country which may have less strict, or no, data protection laws, when compared to the laws in your country. Any transfers of personal data to Baxter affiliates or third parties outside your country will be conducted in compliance with the international data transfer restrictions that apply under applicable data protection laws.

We take legally required steps under applicable data protection law to ensure that adequate safeguards are in place (e.g., standard contractual clauses, data transfer agreements) to protect your personal data in accordance with this Privacy Notice. You may contact us for more information about the safeguards that we have put in place to protect your personal data and your privacy rights when we make cross-border transfers of your personal data.

How long we keep your personal data

Your personal data will be kept for as long as we reasonably consider necessary for achieving the purposes set out above, or for as long as we are legally required to keep it.

However, in the event that you do not use the Service for a period of 12 months then we will treat the account as expired and your personal data will be deleted.

Security

We have reasonable and appropriate security measures in place to protect against the loss, misuse, and alteration of any of your personal data. We maintain reasonable security standards to protect

the personal data that we maintain. If you have any questions about the security of your personal data, please contact us using the information provided below.

Do not track

Certain laws require Baxter to indicate whether we honor “Do Not Track” settings in your browser concerning targeted advertising. As of the effective date of this Privacy Notice, an industry standard has not yet been established on how to respond to these signals, and therefore Baxter does not currently respond to such signals. Instead, we adhere to the standards set out in this Privacy Notice. If you have any questions, please contact us using the information provided below.

Your rights

In certain circumstances, local privacy laws may give you rights with respect to your personal data, as described in more detail below. You can contact us using the information in the Contact Us section below to exercise your rights.

Your rights with respect to your personal data may include the following:

- Withdraw Consent - If we use or share your personal data based on your consent, you may withdraw your consent at any time. Note that withdrawal of your consent will not affect the lawfulness of our uses or sharing of your personal data before you withdraw your consent.
- Access – You may request access to or copies of your personal data. You may also request what types of personal data we have, the purposes for which we process it, and who has received access to your personal data.
- Correction and Deletion – You may request that we correct your personal data if you think it is inaccurate or incomplete. You can also request that we erase or delete your personal data in certain circumstances.
- Restrict Processing – You may request that we restrict the processing of certain personal data.
- Data Portability – You may request that we provide you with your personal data that we obtained from you, and you can ask us to provide it to another entity.
- Object – You may have the right to object to our processing of your personal data for certain purposes.
- Lodge a Complaint – If you believe we are using, disclosing, or otherwise processing your personal data in a way that is not in accordance with applicable law, you can lodge a complaint with the relevant data protection authority in your country.

SUPPLEMENTAL PRIVACY STATEMENT FOR U.S. RESIDENTS

Baxter International Inc. ("Baxter," "we," "our" or "us") provides this supplemental privacy statement (“**Supplement**”) to the Privacy Notice-**My AK 98** App to U.S. residents (“**Consumers**,” “**you**”) to provide you with additional information, as required by applicable state law, on how we use and disclose your information that we collect from you.

If you would like to receive a copy of this Supplement in an alternate format (e.g., printable) or language, please contact us using the information provided below.

If we make material changes to this Supplement, we will post a notice on our site prior to the change becoming effective. We encourage you to periodically review this page for the latest information on our privacy practices.

1. Personal Information Collected and Disclosed

“Personal Information” as used in this Supplement means information that identifies, relates to, describes, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular Consumer or household. The Personal Information Baxter collects from you is listed in the Privacy Notice- **My AK 98** App. In particular, Baxter will collect and disclose the below listed statutory categories of Personal Information from Consumers for the following purposes.

Categories of Personal Information Collected & Disclosed
Identifiers - A real name, email address, account name.
Personal information categories - A name, telephone number, employment, employment history. Some personal information included in this category may overlap with other categories.
Internet or other similar network activity - Information on a consumer's interaction with an application.
Professional or employment-related information - Current or past job history, job title, company name, state in which company located, your affiliation with company (such as division).

We may collect this Personal Information as follows:

- Directly from you when you provide it to us, for example when you contact us with a service inquiry.
- Indirectly from you when you use the Service.

The above listed categories of Personal Information are disclosed to the categories of third parties discussed in the section entitled, “Who may receive your personal data?” in our Privacy Notice-**My AK 98** App above.

The above listed categories of Personal Information are collected and disclosed for the business purposes stated in the Privacy Notice (section entitled, “Why We Collect Your Personal Data”) and retained as stated in the Privacy Notice above (section entitled, “How Long We Keep Your Personal Data”).

2. *Sale, Cross-Context Behavioral Advertising, Targeted Advertising*

Certain state laws regulate the “sale” of Personal Information, which may include not only the traditional selling of data, but also many sharing arrangements where the recipient can use the personal information that they receive for the recipient’s own commercial purposes. State laws may also regulate the disclosure of Personal Information to third parties for cross-context behavioral advertising (“sharing” under the California Consumer Privacy Act of 2018 or “targeted advertising,” as such practice is more commonly referred to).

We do not knowingly “sell” or “share” your Personal Information or the Personal Information of individuals under the age of 16.

3. *Your Privacy Rights*

Depending on your location, you may be afforded certain privacy rights. In general, you may exercise your privacy rights with respect to your Personal Information as set forth in the table below by following the instructions set forth below in this Supplement. Please note that applicable law sets forth a process to follow when evaluating your request, and there are also some exceptions to these rights.

<p align="center">Right to Know/Access</p>	<p>You may have the right to confirm whether your Personal Information is being processed. You may have the right to request that we disclose to you what Personal Information of yours has been collected, used, disclosed, and sold or shared, including, depending on your location:</p> <ul style="list-style-type: none"> ● The categories of Personal Information collected about you; ● The categories of sources from which the Personal Information is collected; ● The business or commercial purpose for collecting, selling, or sharing the Personal Information; ● The categories of Personal information, if any, that were disclosed for a business purpose or sold to third parties; ● The categories of third parties to whom the information was disclosed or sold; and ● The specific pieces of personal information collected about you.
<p align="center">Right to Delete</p>	<p>You may have the right to request deletion of the Personal Information collected about you.</p>
<p align="center">Right to Correct</p>	<p>You may have the right to request the correction of inaccurate personal information that is maintained about you.</p>
<p align="center">Right to Opt-Out of Sale, Cross-Context Behavioral Advertising,</p>	<p>Certain laws may provide you the right to opt-out of the sale of your Personal Information and the use or disclosure of your Personal Information for cross-context behavioral advertising (i.e., “sharing”</p>

Targeted Advertising	under the California Consumer Privacy Act) or targeted advertising. We do not sell or “share” your Personal Information.
Automated Decision-Making	We do not process your Personal Information with automated decision-making processes. However, if we did, you may have the right to request information about the logic involved in certain types of automated decision-making practices and a description of the likely outcome of processes, and the right to opt out of such processes.
Right to Limit the Use of Sensitive Personal Information	We do not collect your Sensitive Personal Information. However, if we did collect your Sensitive Personal Information, you may have the right to limit certain uses of Sensitive Personal Information.
Right to Non-Discrimination	You have the right to not receive discriminatory treatment if you exercise any of the rights conferred to you by law.

4. *How to Exercise Your Rights*

If you would like to exercise any of your rights listed above, please contact us using the information below.

You may also designate an authorized agent to make a request to exercise your rights on your behalf. In order to do so, you must contact us using the information below.

When contacting us to exercise your rights, please adhere to the following guidelines:

- ***Tell Us Which Right You Are Exercising***: Specify which right you want to exercise and the Personal Information to which your request relates (if it does not relate to you). If you are acting as an authorized agent on behalf of someone else, please clearly indicate this fact and indicate your authority to act on their behalf.
- ***Help Us Verify Your Identity***: Contact us using the information below and provide us with enough information to verify your identity. Please note that if we cannot initially verify your identity, we may request additional information to complete the verification process. Any Personal Information you disclose to us for purposes of verifying your identity will solely be used for the purpose of verification.
- ***Direct Response Delivery***: Inform us of the delivery mechanism with which you prefer to receive our response. You may specify, for example, email, mail, or through your account (if you have one with us).

Please note that you do not need to create an account with us in order to make a request to exercise your rights hereunder.

Please contact us to appeal any decision made on your request.

5. *Responses to Your Requests*

Receipt of your request will be confirmed consistent with applicable law. You will generally receive a response to your request within forty-five (45) days. However, where reasonably necessary and where permitted by law, the response time may be extended by an additional forty-five (45) days, provided you are given notice of such extension first. If the information is

provided to you electronically, it will be in a portable format and, to the extent technically feasible, in a machine readable, readily useable format that allows you to freely transmit this information without hindrance.

Please note that you will not be charged for making a request, provided that you make no more than two (2) requests per year. Where permitted by law, your request may be denied, for example, if your requests are determined to be unfounded or excessive (e.g., repetitive in nature), or a reasonable fee may be charged. In these circumstances, you will receive a notice regarding this denial and the reason for such denial.
